

Coach) from 15th to 27th October, 2018 (13 Days) at SAI, Gandhinagar, in preparation for participation of the Indian Deaf Badminton Team at 5th Asia Pacific Badminton Championship scheduled to be held at Kuala Lumpur, Malaysia from 28th October to 04th November, 2018, as per the following terms and conditions:-

1. Boarding Charges @ Rs.690/- per head per day for Seniors and Rs.480/- for Juniors.
2. Lodging Charges @ Rs 1200/- per head per day (Out of Rs.1200/- Rs.900/- will be kept at SAI, HQ).
3. Overhead charges @Rs.300/- per day per persons.
4. Food Supplements @Rs.430/- per head per day for Seniors & Rs.320/- per head per day for Juniors (only for athletes).
5. Field of Play (FOP) Charges @ Rs.10000/- per day. (To be kept at SAI H.Q)
6. Medical facilities provided on need basis.
7. Travelling for Senior Players/Coaches by air (restricted to economy class) provided, journey is more than 500 kms/10 hours. Else, restricted to AC II train fare for coaches and for Juniors - by air (restricted to economy class) provided journey is more than 1200 kms/18 hours. Else, restricted to AC III train fare.
8. List of Campers are enclosed.
9. List of campers reported for the camp should be forwarded to the TEAMS Division immediately after 2nd Day from the Commencement date of the camp as per sanction.
10. Any inclusion/deletion of National Coaching Campers should not be entertained without prior approval of the TEAMS Division.






