3. I am also directed to convey the sanction of Competent Authority to the payment of a sum of Rs.7,15,950/- i.e. 75% to the total estimated expenditure of Rs.9,54,600/- as an advance to All India Sports Council of the Deaf (AISCD) in respect of Registration fee, ISCD fee, Hospitality Boarding & lodging.

4. The amount sanctioned herein will be drawn by the Drawing & Disbursing Officer, Sports Authority of India on the prescribed bill immediately for disbursing the same to grantee through Electronic Clearing System. This grant is of non-

recurring nature.

The grant is subject to the conditions mentioned below:-

i) That the grantee shall execute a bond for the full amount of grant in the prescribed proforma on a non-judicial stamp paper in acceptance of the term and conditions of the grant duly executed by the authorized signatory of the grantee and two sureties and witnesses with complete permanent addresses.

The grantee shall maintain subsidiary accounts of the grant received from the

Sports Authority of India.

The grantee shall maintain the register of assets in the prescribed form GFR-19. The assets acquired wholly or substantially out of the grant except those declared as obsolete and unserviceable or condemned as per the procedure laid down in the General Financial Rules shall not be disposed off without the prior approval of the Sports Authority of India.

iv) The grantee shall not divert the grants and entrust execution of the scheme or work concerned to another Institution or Organizations and shall abide by the terms & conditions of the grant. If the grantee fails to utilize the grant, for the purpose for which the same has been sanctioned, the grantee will required to refund the entire amount of the grant with interest thereon @ 10% per annum.

v) The Utilization Certificate in the prescribed form GFR – 19 A disclosing whether the specified, quantified and qualitative targets that should have been reached against the amount utilized, were in fact reached and if not the reasons therefore should be submitted within six months of the completion of the program along with the audited statement of accounts. The UC should be checked and signed by the Chartered Accountant with reference to the initial and subsidiary accounts of the grant to be maintained by the grantee as per GFRs.

The performance-cum-achievement report in respect of the above event for which the grant has been sanctioned should be forwarded to the TEAMS DIVISION, Sports Authority of India with a copy to Government Observer within one week

of the completion of event.

vii) That some photographs of the events, i.e. events, medal winners etc. with sample invitation cards for opening and closing ceremony and copies of newspaper clippings related to the event preferably in National and Regional dailies be sent to this office along with performance-cum-achievement report.

viii) That the amount in INR will be subject to the actual rate of Foreign Exchange on the date of payment by the Federation. The difference, if any, in INR will be

adjusted.

ix) There is no reason to believe that the grantee is involved in corrupt practice.

x) That no advertisement of Tobacco and Liquor will be displayed during the event, the breach of which entails the cancellation of grant.

xi) Amount of grant should be utilized only for the purpose for which it is sanctioned and unspent balance of grant shall be refunded by the grantee institution immediately after conclusion of the event.

xii) The grantee should maintain separate accounts for the grants released by the Sports Authority of India. The accounts of the amount so paid to the grantee shall be open to check by an officer deputed by Sports Authority of India or the

Spiral

Government in addition to other statutory authorities to ensure proper utilization of the funds and that no profits are earned out this.

- xiii) The grantee shall also submit consolidated accounts of the grants received from other Ministries/Departments/State Governments for detailed checking by the Sports Authority of India, in addition to the separate annual accounts on the activities implemented with the grants released by the Sports Authority of India.
- xiv) The grant is further subject to the conditions laid down in General Financial Rules as amended from time to time.
- xv) The fact the program is sponsored by the Ministry of Youth Affairs and Sports/ Sports Authority of India should be prominently highlighted and displayed while inviting people and holding functions/programs/events etc.
- wi) When the Sports Authority of India/Government of India/State Government has reasons to believe that the sanctioned money is not being utilized for the approved purposes, the payment of the grant will be stopped. If the reply to the show cause notice is not satisfactory, the earlier grant will be recovered with interest as mentioned in Clause IV above.
- xvii) The grantee institution or organization should exercise reasonable economy in the working of the approved projects.
- xviii) As per GFR-212(1), the accounts of grantee institution or organization shall be opened to inspection by the Ministry of Youth Affairs & Sports/Sports Authority of India and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and Internal Audit of Sports Authority of India, New Delhi, whenever the grantee is called upon to do so.

The above sanction has been issued under the powers delegated to the Director General/Secretary/Executive Director of Sports Authority of India. It is certified that the grant being released is in conformity with the rules and regulations of the scheme as approved by the Ministry of Youth Affairs & Sports.

- 5. The amount of Rs. 7,15,950/-(Rupees Seven Lakhs Fifteen Thousand Nine Hundred Fifty only) shall be drawn and transferred to All India Sports Council of the Deaf (AISCD) for the above participation.
- 6. The amount of grant will be debitable to the Major Head 49.0500, Sub Head ------(Assistance to National Sports Federations) for the Financial Year 2018-19.

But with great efforts from the MYAS, SAI and MEA we got the approvals.

It is regretted to state that since the Indian Deaf Chess Team arrived Manchester late, which resulted in the payment for the accommodation being overdue. Thus the original booking for the twin room (breakfast included) for Pound 100.00 GBP for two person (1 persons = 50.00) became invalid, so it was necessary to relocate to another hotel which had a slightly higher rate i.e. the twin room (breakfast included) for two persons per night was Pound 127.30 GBP (1 person = 63.65).

In the absence of Mr. Alaguraja, Mr. Mahendra Pal had changed from Open Individual to Team Men Event and hence Mr. Subhash Kapoor, who is an ex-international Chess player, moved to play in Open Individual Event.
