1. Expenditure for boarding, lodging, food supplements, TA, local transport, sports kit, insurance for the said activity are to be booked under the budget for ACTC as per the norms of National Coaching Camp.
2. Medical as per actual.
3. Please ensure that SOP issued by SAI and MHA guidelines for COVID-19 are strictly adhered to.
4. List of athletes reported for the sports activity should be forwarded to TEAMS DIVISION on the 3rd day from the commencement of the activity by the coach.
5. The expenditure may be debited under the head "General Assistance for holding Coaching Camp (Head 49.0500).
6. The monitoring of attendance on daily basis shall be maintained by the coach.
7. Sports kit for 06 Campers @Rs. 20,000/- per person (Once in a year) to be provided by Director (ES), SAI HQ for further distribution to the Campers at JLN Stadium.



8. The financial implications are as follows:

- Boarding for **06 Campers** INR @690/- person per day at JLN Stadium, New Delhi.







Further to the Administrative Approval issued from File. no. **SAI/TD/AISCD/F.EXPO./DEAF SWIMMING/2021-22 (D-7)** dated 05.11.2021 on the above mentioned subject, I am directed to convey the financial sanction of the Competent Authority, in principle, for the subject International Exposure, as per following break-up of financial assistance and Terms and Conditions:-



2. I am also directed to convey the sanction of the Competent Authority for the payment of a sum of **Rs. 4,10,025/- (Rupees Four Lakh Ten Thousand and Twenty Five Only)** towards full Boarding Accommodation, Visa Fees, Entry Fees ICSD & OC and RT-PCR Test to the All India Sports Council of the Deaf as 75% advance grant to meet the expenditure on participation of team in the above mentioned event. The balance 25% grant will be released on receipt of UC, Audited Accounts along with necessary vouchers/invoice duly certified by the Chartered Accountant and signed by the President of the Federation/ Association within one month after the event is over to Sports Authority of India in the enclosed formats.
3. The amount sanctioned herein will be drawn by the Drawing & Disbursing Officer, Sports Authority of India on the prescribed bill immediately for disbursing the same to grantee through Electronic Clearing System. This grant is of non-recurring nature.
4. The grant is subject to the conditions mentioned below :-
- (i) That the grantee shall execute a bond for the full amount of grant in the prescribed Performa on a non-judicial stamp paper in acceptance of the terms and conditions of the grant duly executed by the authorized signatory of the grantee and two sureties and witnesses with complete permanent addresses.
 - (ii) The grantee shall maintain subsidiary accounts of the grant received from the Sports Authority of India.
 - (iii) The grantee shall maintain the register of assets in the prescribed form GFR-12 A. The assets acquired wholly or substantially out of the grant except those declared as obsolete and unserviceable or condemned as per the procedure laid down in the General Financial Rules shall not be disposed off without the prior approval of the Sports Authority of India.
 - (iv) The grantee shall not divert the grants and entrust execution of the scheme or work concerned to another Institution or Organizations and shall abide by the terms & conditions of the grant. If the grantee fails to utilize the grant, for the purpose for which the same has been sanctioned, the grantee will required to refund the entire amount of the grant with interest thereon @ 10% per annum.
 - (v) The Utilization Certificate in the prescribed form **GFR - 12 A** disclosing whether the specified, quantified and qualitative targets that should have been reached against the amount utilized, were in fact reached and if not the reasons therefore should be submitted within six months of the completion of the programme along with the audited statement of accounts. The UC should be checked and signed by the Chartered Accountant with reference to the initial and subsidiary accounts of the grant to be maintained by the grantee as per GFRs.
 - (vi) The performance-cum-achievement report in respect of the above event for which the grant has been sanctioned should be forwarded to the TEAMS DIVISION, Sports Authority of India with a copy to Government Observer within one week of the completion of event.
 - (vii) That some photographs of the events, i.e. events, medal winners etc. with sample invitation cards for opening and closing ceremony and copies of newspaper clippings related to the



- event preferably in National and Regional dailies be sent to this office along with performance-cum-achievement report.
- (viii) That the amount in INR will be subject to the actual rate of Foreign Exchange on the date of payment by the Federation. The difference, if any, in INR will be adjusted.
- (ix) There is no reason to believe that the grantee is involved in corrupt practice.
- (x) That no advertisement of Tobacco and Liquor will be displayed during the event, the breach of which entails the cancellation of grant.
- (xi) Amount of grant should be utilized only for the purpose for which it is sanctioned and unspent balance of grant shall be refunded by the grantee institution immediately after conclusion of the event.
- (xii) The grantee should maintain separate accounts for the grants released by the Sports Authority of India. The accounts of the amount so paid to the grantee shall be open to check by an officer deputed by Sports Authority of India or the Government in addition to other statutory authorities to ensure proper utilization of the funds and that no profits are earned out this.
- (xiii) The grantee shall also submit consolidated accounts of the grants received from other Ministries/Departments/State Governments for detailed checking by the Sports Authority of India, in addition to the separate annual accounts on the activities implemented with the grants released by the Sports Authority of India.
- (xiv) The grant is further subject to the conditions laid down in General Financial Rules as amended from time to time.
- (xv) The fact the programmed is sponsored by the Ministry of Youth Affairs and Sports/ Sports Authority of India should be prominently highlighted and displayed while inviting people and holding functions/programmers/events etc.
- (xvi) When the Sports Authority of India/Government of India/State Government has reasons to believe that the sanctioned money is not being utilized for the approved purposes, the payment of the grant will be stopped. If the reply to the show cause notice is not satisfactory, the earlier grant will be recovered with interest as mentioned in Clause IV above.
- (xvii) The grantee institution or organization should exercise reasonable economy in the working of the approved projects.
- (xviii) As per GFR-212(1), the accounts of grantee institution or organization shall be opened to inspection by the Ministry of Youth Affairs & Sports/Sports Authority of India and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and Internal Audit of Sports Authority of India, New Delhi, whenever the grantee is called upon to do so.
5. The above sanction has been issued under the powers delegated to the Director General/Secretary/Executive Director of Sports Authority of India. It is certified that the grant being released is in conformity with the rules and regulations of the scheme as approved by the Ministry of Youth Affairs & Sports.



With Reference to the above Cited Subject.

I, Mayank Diwan Asst Swimming Coach of Sports Authority of India. Currently Posted at SAI TOPS-Division J.N. Stadium, (Head Office), New Delhi. I was given an Opportunity to be the Head Coach/ Interpreter of National Coaching Camp for Deaf Swimming Team consisting of 06 Campers (03 Men + 02 Women + 01 Coach/Interpreter), held at Defence Colony, Swimming Pool, New Delhi from 5th to 13th November 2021, (09 days) in preparation for the 1st World Deaf Short Course Swimming Championship at Gliwice, Poland.

Our Lodging, Boarding and local transport was provided at JLN Stadium, New Delhi. Three (03) swimmers (Sneha R., Subiya Mullani & Aadesh Rukadikar) joined the camp on 4th Nov 2021 evening and rest of the campers including myself joined on 5th Nov 2021 morning. Joining to the National Coaching was submitted to the Administrator, JLN Stadium, New Delhi on 5th Nov 2021 (Enclosed).

Our training started on 5th Nov 2021 evening where I took Swimming Endurance test to check their endurance and capability. All the swimmers pass the test. Our main aim in the camp was to prepare well for the World Short Course Swimming Championship and get medal for the country. We mainly worked on the Start, turn and finish, as the Championship is the Short Course (25mtr), Start and Turn plays a vital role. Fitness and Speed test were also taken, where the swimmers pass the test with flying colors and were very motivated for the World Championship. Our training timings were Morning from 6:45 am to 9am & Evening from 3:45pm to 6:30pm.

As our Lodging, Boarding and local transport was provided at Sports Hostel, JLN Stadium, New Delhi. Food was really good and staying facility was very clean and hygienic. All the Swimmers follows daily routine punctually and discipline of the Sports Hostel. Attendance sheet is enclosed. On 12th Nov 2021, all the campers received their Sports kit and appreciated the sports kit provided by Sports Authority of India. (Receiving of Sports kit duly signed by the campers Enclosed).
