1. Medical expenditure on actual basis, provided the said injury is not covered under Insurance. However Regional Center may incurred the expenditure immediately and claimed the same amount from Insurance agency. Subsequently a separate record be maintained in such cases by the concern Regional Center.
2. List of campers reported for the camp should be forwarded to the TEAMS Division immediately after 2nd day from the commencement of the camp.
3. Any inclusion/deletion of National Coaching Campers should not be entertained without prior approval of the TEAMS Division.
4. On conclusion of the Coaching Camp Regional Center shall submit a report on coaching camp within 10 days to the TEAMS Division, New Delhi.
5. The Regional Center/Organizer to make all the necessary arrangements as per approved norms/approved by Competent Authority, for the camp sanctioned.
6. The Expenditure may be debited under the head of Financial Assistance to NSFs.
7. Sports kit (if approved above) will be issued by concerned Regional Centre once in a year as per norms, irrespective of number of the camps attended.
8. Food Supplements, if applicable, will be procured by the NSF's and distributed to the players through the concerned Regional Centre after stock entry in respective stock register, Cost of the same will be reimbursed to the NSF's on receipt of income and expenditure statement and Utilization Certificate (as per GFR-2017 Form 12-A) audited by CAG empanelled Chartered Accountant and counter signed by authorized signatory of concerned NSF.
9. The head of Institutions / Regional Centre should submit the monthly expenditure statement discipline and head wise on the last working day of the month and utilization certificate within 15 days after completion of the camp to the TEAMS Division.
10. An advance of Rs. 0/- as 75% of Rs. 0/- may be released to **All India Sports Council of the Deaf** for making arrangements from by concerned Regional Centre for smooth

conduct of the National Coaching Camp. The Bills /Account of the camp will be settled by Regional Centre on receipt of expenditure statement along with utilization certificates in the prescribed form GFR – 2017 (form 12-A) duly certified by Chartered Accountant firm empanelled with CAG and counter signed by authorized signatory of the concerned NSF.





Further to the Administrative Approval issued from File. no. **SAI/TD/F.EXPO/AISCD/F.EXPO./WORLD DEAF JUDO CHAMPIONSHIP/2021-22 (D-5)** dated 19.10.2021 on the above mentioned subject, I am directed to convey the financial sanction of the Competent Authority, in principle, for the subject International Exposure, as per following break-up of financial assistance and Terms and Conditions:-

2. I am also directed to convey the sanction of the Competent Authority for the payment of a sum of **Rs. 4,67,700/- (Rupees Four Lakh Sixty Seven Thousand and Seven Hundred Only)** towards Full Boarding & Accommodation, Visa Fees, Entry Fees to ICSD & OC and RT-PCR Test to the All India Sports Council of the Deaf as 75% advance grant to meet the expenditure on participation of team in the above mentioned event. The balance 25% grant will be released on receipt of Audited Accounts along with necessary vouchers/invoice duly certified by the Chartered Accountant and signed by the President of the Federation/ Association within one month after the event is over to Sports Authority of India in the enclosed formats.



3. The amount sanctioned herein will be drawn by the Drawing & Disbursing Officer, Sports Authority of India on the prescribed bill immediately for disbursing the same to grantee through Electronic Clearing System. This grant is of non-recurring nature.
4. The grant is subject to the conditions mentioned below :-
- (i) That the grantee shall execute a bond for the full amount of grant in the prescribed Performa on a non-judicial stamp paper in acceptance of the terms and conditions of the grant duly executed by the authorized signatory of the grantee and two sureties and witnesses with complete permanent addresses.
 - (ii) The grantee shall maintain subsidiary accounts of the grant received from the Sports Authority of India.
 - (iii) The grantee shall maintain the register of assets in the prescribed form GFR-12 A. The assets acquired wholly or substantially out of the grant except those declared as obsolete and unserviceable or condemned as per the procedure laid down in the General Financial Rules shall not be disposed off without the prior approval of the Sports Authority of India.
 - (iv) The grantee shall not divert the grants and entrust execution of the scheme or work concerned to another Institution or Organizations and shall abide by the terms & conditions of the grant. If the grantee fails to utilize the grant, for the purpose for which the same has been sanctioned, the grantee will required to refund the entire amount of the grant with interest thereon @ 10% per annum.
 - (v) The Utilization Certificate in the prescribed form **GFR - 12 A** disclosing whether the specified, quantified and qualitative targets that should have been reached against the amount utilized, were in fact reached and if not the reasons therefore should be submitted within six months of the completion of the programme along with the audited statement of accounts. The UC should be checked and signed by the Chartered Accountant with reference to the initial and subsidiary accounts of the grant to be maintained by the grantee as per GFRs.
 - (vi) The performance-cum-achievement report in respect of the above event for which the grant has been sanctioned should be forwarded to the TEAMS DIVISION, Sports Authority of India with a copy to Government Observer within one week of the completion of event.
 - (vii) That some photographs of the events, i.e. events, medal winners etc. with sample invitation cards for opening and closing ceremony and copies of newspaper clippings related to the event preferably in National and Regional dailies be sent to this office along with performance-cum-achievement report.
 - (viii) That the amount in INR will be subject to the actual rate of Foreign Exchange on the date of payment by the Federation. The difference, if any, in INR will be adjusted.
 - (ix) There is no reason to believe that the grantee is involved in corrupt practice.
 - (x) That no advertisement of Tobacco and Liquor will be displayed during the event, the breach of which entails the cancellation of grant.
 - (xi) Amount of grant should be utilized only for the purpose for which it is sanctioned and unspent balance of grant shall be refunded by the grantee institution immediately after conclusion of the event.
 - (xii) The grantee should maintain separate accounts for the grants released by the Sports Authority of India. The accounts of the amount so paid to the grantee shall be open to check by an officer deputed by Sports Authority of India or the Government in addition to other statutory authorities to ensure proper utilization of the funds and that no profits are earned out this.
 - (xiii) The grantee shall also submit consolidated accounts of the grants received from other Ministries/Departments/State Governments for detailed checking by the Sports Authority of India, in addition to the separate annual accounts on the activities implemented with the grants released by the Sports Authority of India.
 - (xiv) The grant is further subject to the conditions laid down in General Financial Rules as amended from time to time.



- (xv) The fact the programmed is sponsored by the Ministry of Youth Affairs and Sports/ Sports Authority of India should be prominently highlighted and displayed while inviting people and holding functions/programmers/events etc.
- (xvi) When the Sports Authority of India/Government of India/State Government has reasons to believe that the sanctioned money is not being utilized for the approved purposes, the payment of the grant will be stopped. If the reply to the show cause notice is not satisfactory, the earlier grant will be recovered with interest as mentioned in Clause IV above.
- (xvii) The grantee institution or organization should exercise reasonable economy in the working of the approved projects.
- (xviii) As per GFR-212(1), the accounts of grantee institution or organization shall be opened to inspection by the Ministry of Youth Affairs & Sports/Sports Authority of India and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and Internal Audit of Sports Authority of India, New Delhi, whenever the grantee is called upon to do so.
5. The above sanction has been issued under the powers delegated to the Director General/Secretary/Executive Director of Sports Authority of India. It is certified that the grant being released is in conformity with the rules and regulations of the scheme as approved by the Ministry of Youth Affairs & Sports.
6. The amount of **Rs. 4,67,700/- (Rupees Four Lakh Sixty Seven Thousand Seven Hundred Only)** has been released vide Sanction order no. T- 190 dated 20.10.2021. to All India Sports Council of the Deaf as an advance.
7. The amount of grant will be debitible to the Major Head 49.0500, Sub Head 49.0511 (**Assistance to National Sports Federations**) for the Financial Year 2021-22.

I am submitting my report.

The camp for the World Deaf Judo Championships held at Indira Gandhi Stadium, New Delhi from 18th to 25th October 2021.

The team reached at France on 26th October 2021, the following are the performance of the team.

Women (Individual)

1. **Tiwari Divya** :- She played in below 48 kgs with Huitron Maria of Mexico in her first bout but she lost and got the chance to play in repechage bout with Didorenko Yelyzaveta of Ukraine, where again she lost and got 7th place in her weight Group.
2. **Umed Nirchara** :- She played in below 52 kgs with Shostak Anna of Ukraine in her first bout but she lost and got the chance to play in repechage bout with Kuznetsova Zhanna of RCDS, where again she lost and got 7th place in her weight Group.
3. **Mehak Rakhshinda** :- She played in below 78 kgs with RCDS in her first bout but she lost and got the chance to play in repechage bout with Ukraine , where again she lost and got 5th place in her weight Group.

Men (Individual)

1. **Khan Amaan** :- He played in below 60 kgs with Scheller Daniel of Germany in his first bout but he lost and got the chance to play in repechage bout with Roshchenkov Vladyslav of Ukraine, where again he lost in his weight Group and did not get any place.

2. **Khajuria Vishal** :- He played in below 66 kgs with Askerov Ruslan of RCDS in his first bout but he lost and got the chance to play in recharge bout with Yildiz Enes of Turkey, where again he lost in his weight Group and did not get any place.
3. **Soni Sumit** :- He played in below 73 kgs with Dundar Emrah of Turkey in his first bout but he lost and not got the chance to play in recharge.

Team Championships

In the team championships India first played with Turkey Women team and lost her first round and in the second round India played with Korea and get walkover by Korea and won Bronze Medal in the team championships.


