Sub: - 1st World Deaf Youth and 5th World Deaf Athletics Championships, Taipei, Chinese Taipei on July 12 to 21, 2024 – Regarding

Ref: - Our Memorandum – 1 dated 03-04-2024 (AISCD/CDS/2024-2025)

1. In continuation with our Council Memorandum – 1 dated 03-04-2024 and following the 10-Day National Athletics Coaching Camp cum Selection Trial have been conducted at the Atal Bihari Vajpayee Training Centre for Disability Sports, Gwalior successfully with 09 Men + 08 Women + 04 Youth Boys + 10 Youth Girls.

2. AISCD has submitted the ACTC Proposal Templates 2024-2025 totalling to Rs. 20.51 crore with many different Foreign Exposures, National Coaching Camp, National Championships, etc to SAI and MYAS and AISCD Officials have attended the such meeting under the chairpersonship of MYAS Secretary (Sports) on 06-03-2024. It is understood that our proposal had been pending. This is for your kind information and knowledge.

3. Kindly note that the criteria for the selection of both Men and Women is based on the 5th place and above of the Previous 24th Summer Deaflympics, Caxias Du Sul, Brazil in 2022. Following this, on the performance based in the 10-Day National Coaching Camp cum Selection Trial at Gwalior, Madhya Pradesh on April 12 to 22, 2024, 08 Men + 04 Women + 05 Youth Boys + 02 Youth Girls have been selected to attend Coaching camp for the forthcoming 1st World Deaf Youth and 5th World Deaf Athletics Championships, Taipei, Chinese Taipei on July 13 to 23, 2024 subject to the approval from the Ministry of Youth Affairs & Sports and also Fitness Certificate from the Government Specialist. List of the 19 Probable Athletes and 06 Officials is attached herewith.

4. As per the ICSD Online Management Systems, it is stated that athletes who must be born between 01-01-2005 and 31-12-2008 can enter in the 1st World Deaf Youth Athletics Championships 2024 while athletes who must be born on or before 31-12-2008 can enter in the 5th World Deaf Athletics Championships 2024. Regrettably Mr. Himansh K (Born on 08-03-2009) is not eligible to be selected to join India Team this time.

5. As per the Bulletin from the Organising Committee of the World Deaf Athletics Championships, Taipei, Chinese Taipei, the tentative dates are given below: -


